Community foundation staffing

KCDF has eighteen paid staff.

Legal environment

The legal environment in Kenya is not very favourable to community foundations. There are no laws that give incentives to giving by individuals, but there are some incentives for companies which are not yet in effect.

Key trends affecting community foundation development

Kenya does not have well-organized giving mechanisms in place or appreciated ways of doing it. A lot of education is needed. Well-endowed people are not much informed about different ways of giving back....there are issues of creating confidence among people to give to institutions. Sustainability - creating a good funding base for a community foundation to do their business is not easy, particularly through local fundraising targeting individuals.

Comment: Community foundations are too few to bring changes that can be significantly felt at the moment.

Examples:

- A number of communities are now growing food with (the use) of better technology.
- A good number of young people are engaged positively in constructive activities in their communities.
- A good number of orphans receiving scholarships for education.
- Hundreds of Girls from disadvantaged families are now receiving mentorship and education support from professional women in employment (give back circle)

History of the community foundation¹

The Kenya Community Development Foundation (KCDF) was set up in 1997. Founders were Kenyan development practitioners and scholars who were concerned about the issue of sustainability of community-based initiatives focusing on poverty reduction and social justice, as well as persistent donor dependency. Although a non-profit, it is registered under the Companies Act as a Company Limited by Guarantee without share capital (a non-profit company). KCDF is Kenya's only community foundation.
