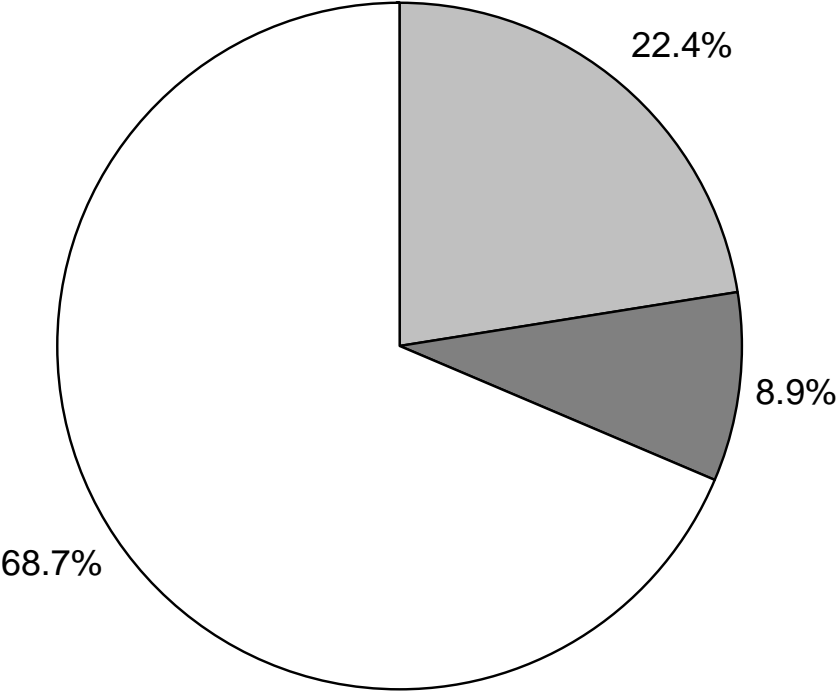

Figure 2A: Percent of All Medicaid and PeachCare Enrolled Children Receiving Any Dental Service, CY2001

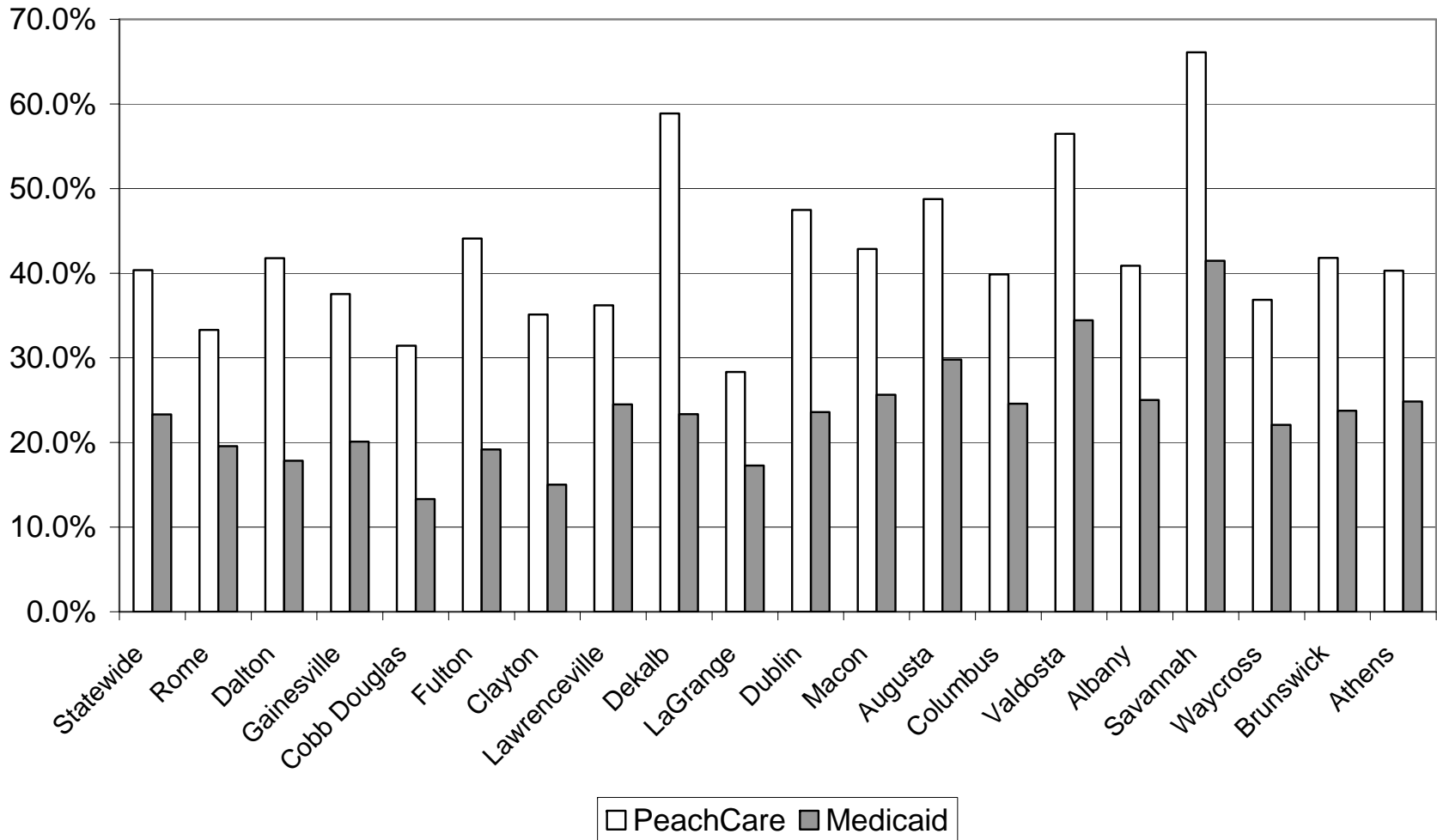


Figure 2B: Percent of All Medicaid and PeachCare Enrolled Children Receiving Any Dental Service, CY2002

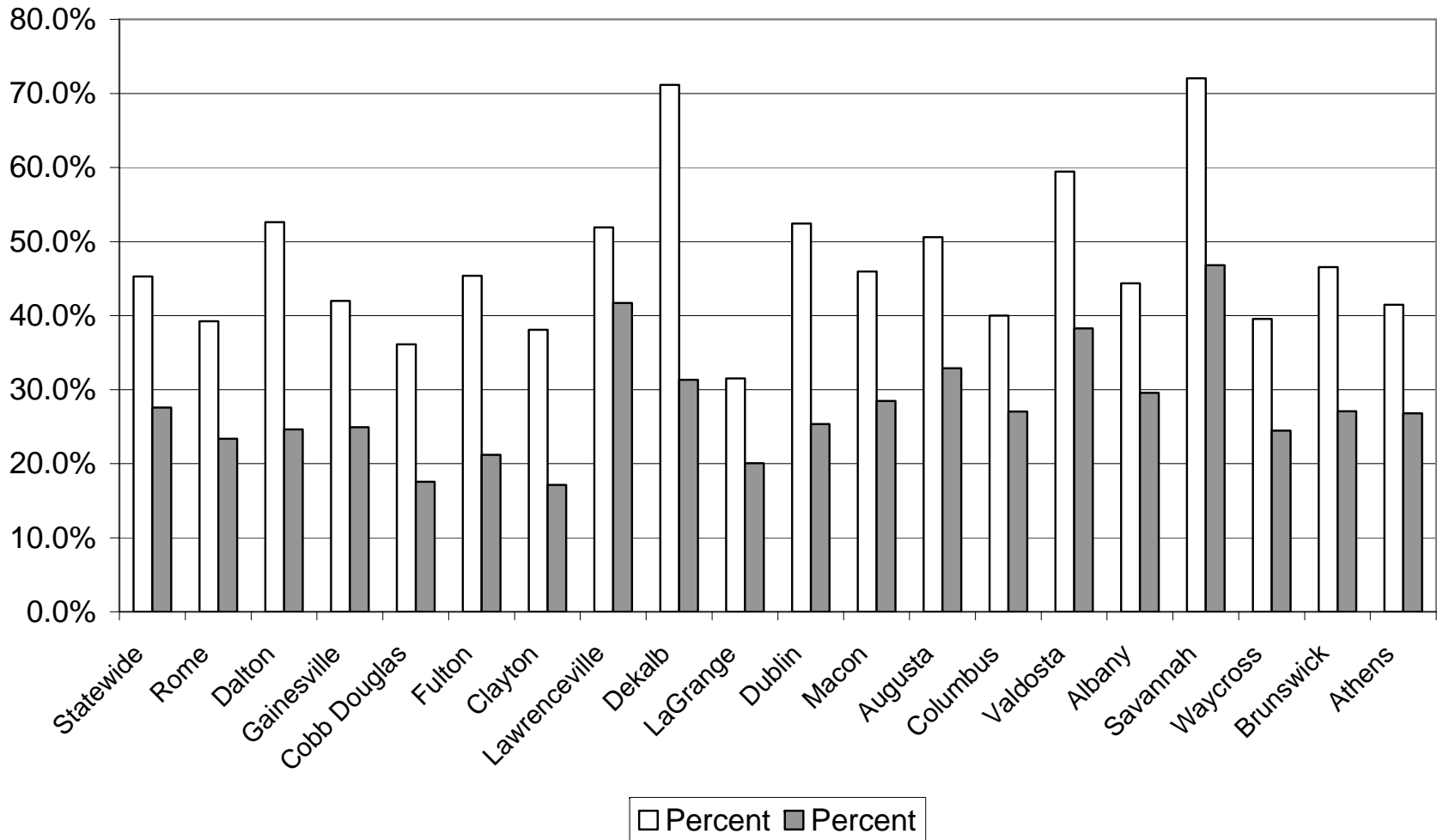


Figure 2C: Percent of All Medicaid and PeachCare Children Receiving Any Dental Service, CY1999, CY2000, CY2001, CY2002

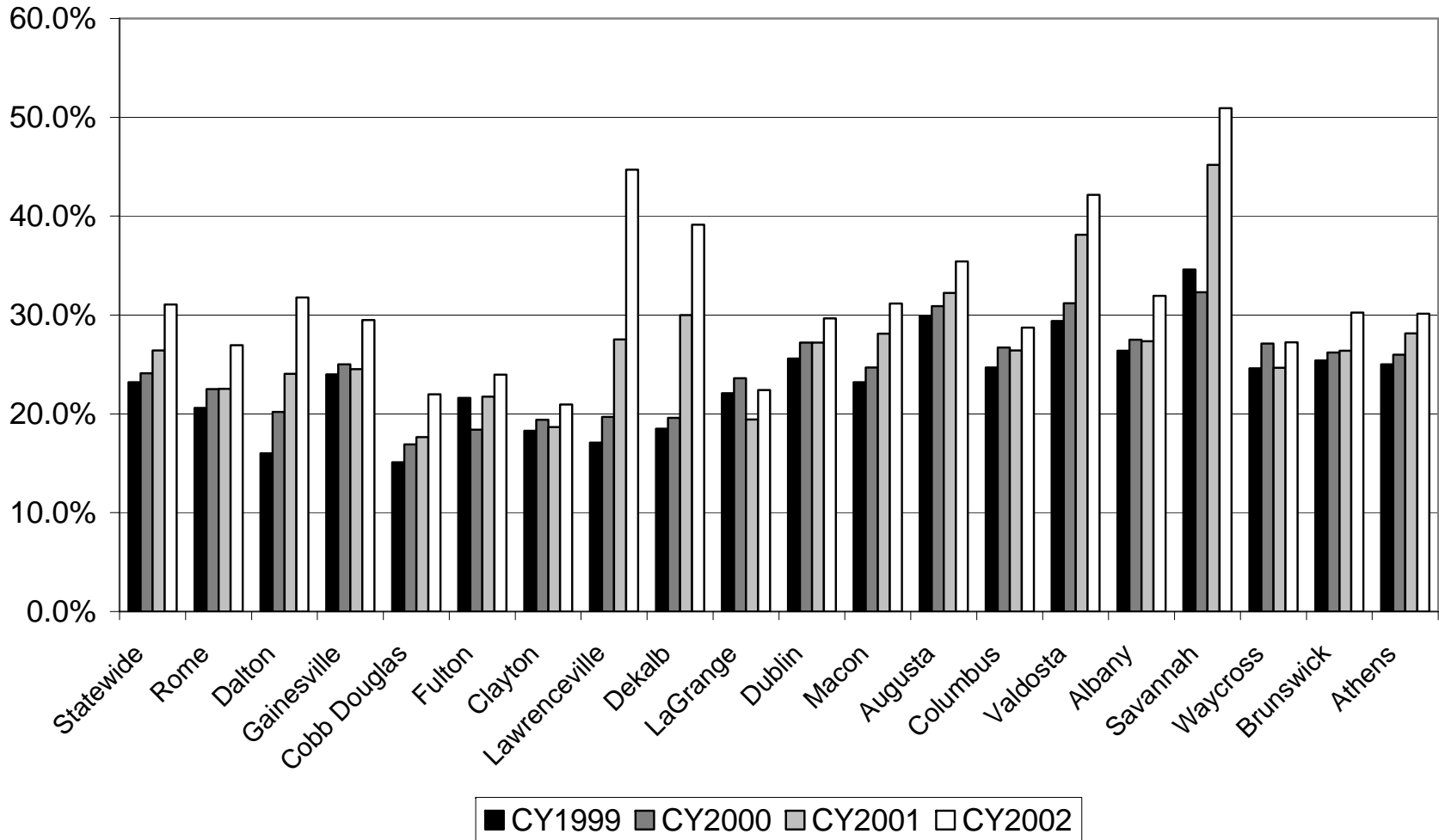


Figure 2D: Percent of All PeachCare Enrolled Children Receiving Any Dental Services, CY2000, CY2001, CY2002

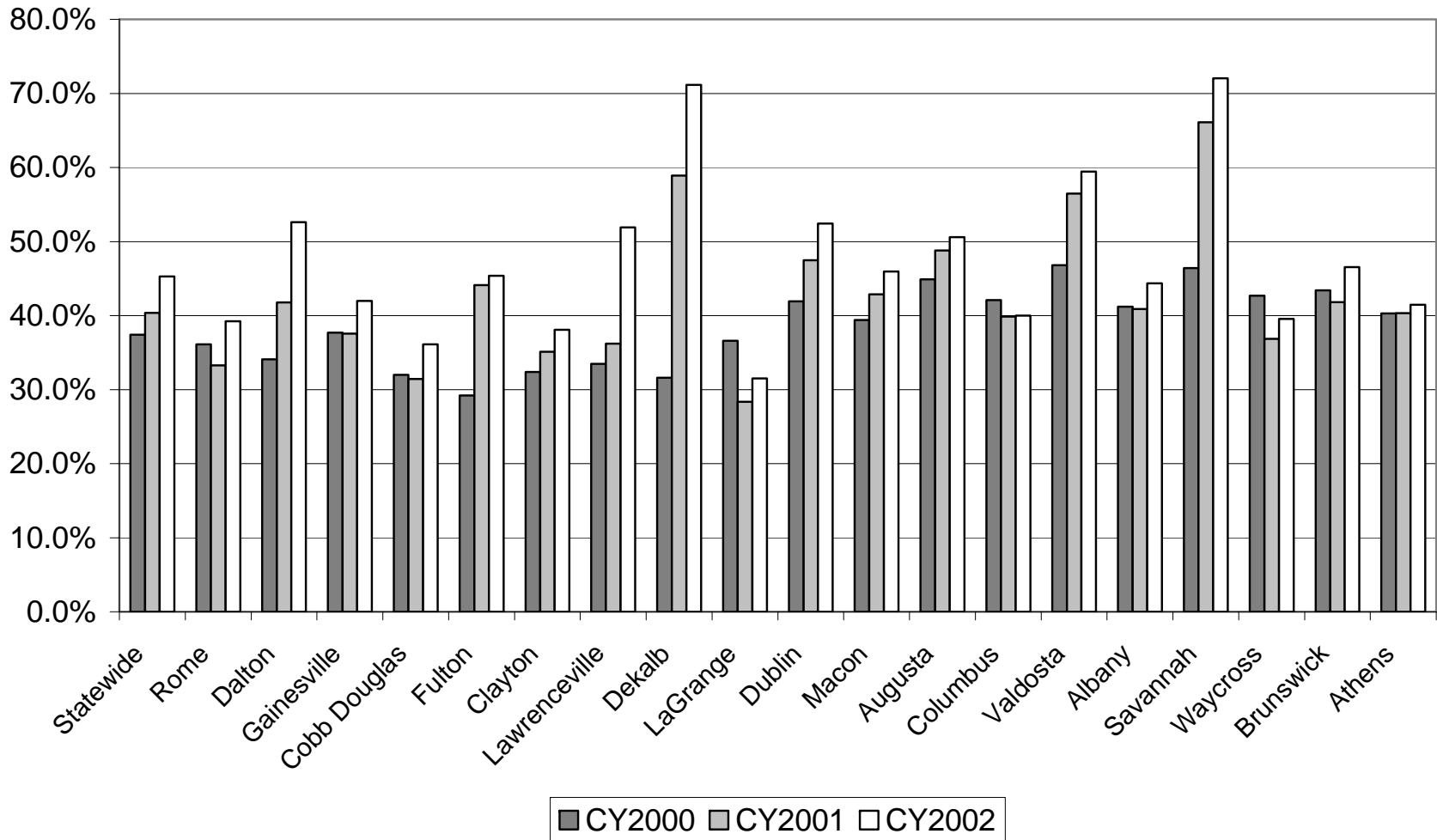


Figure 2E: Percent of All Medicaid Enrolled Children Receiving Any Dental Service, CY2000, CY2001, CY2002

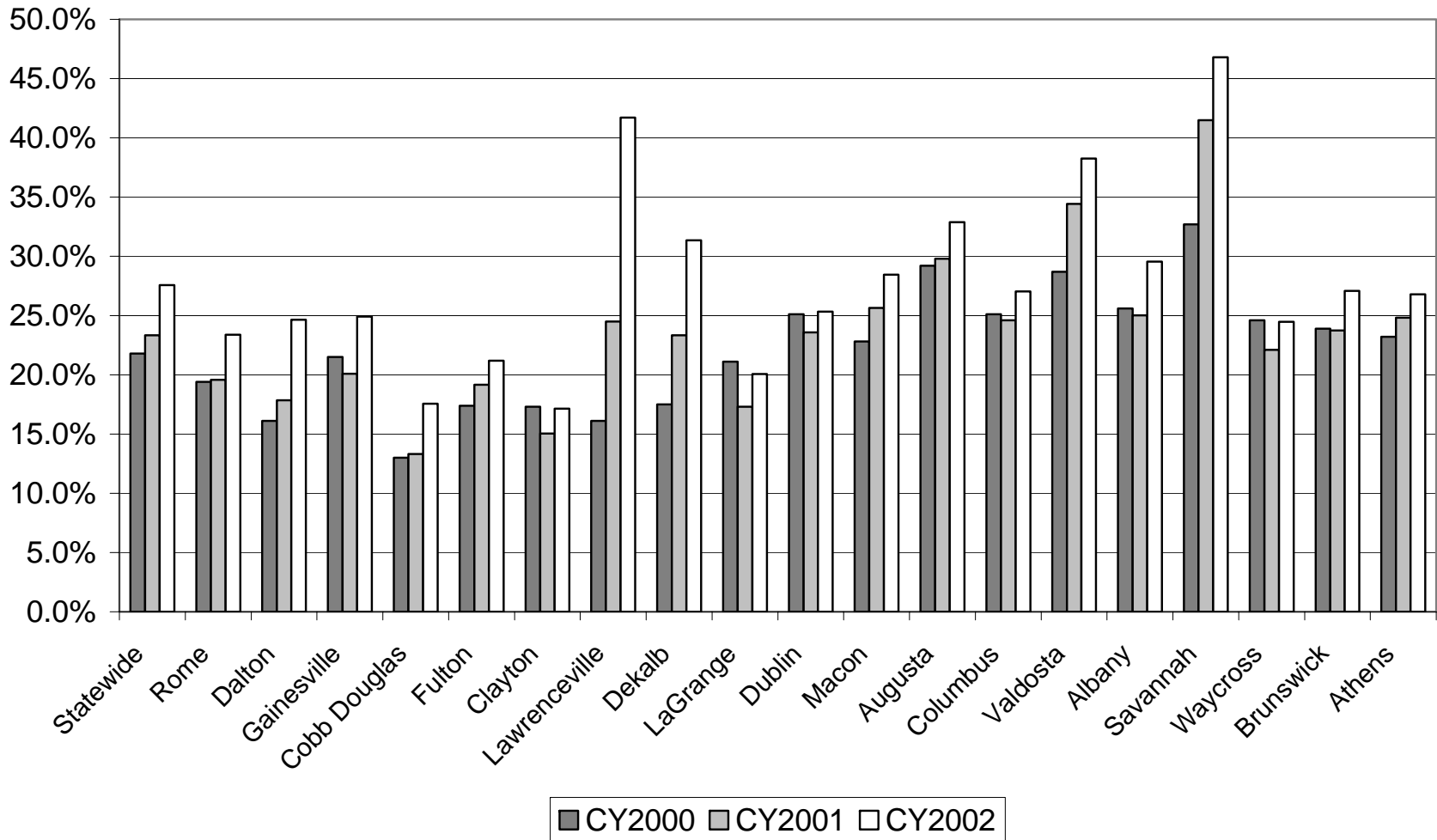


Figure 3: Percent of Children Enrolled in Medicaid or PeachCare Who Had at Least One Preventive Dental Service, CY1999, CY2000, CY2001, CY2002

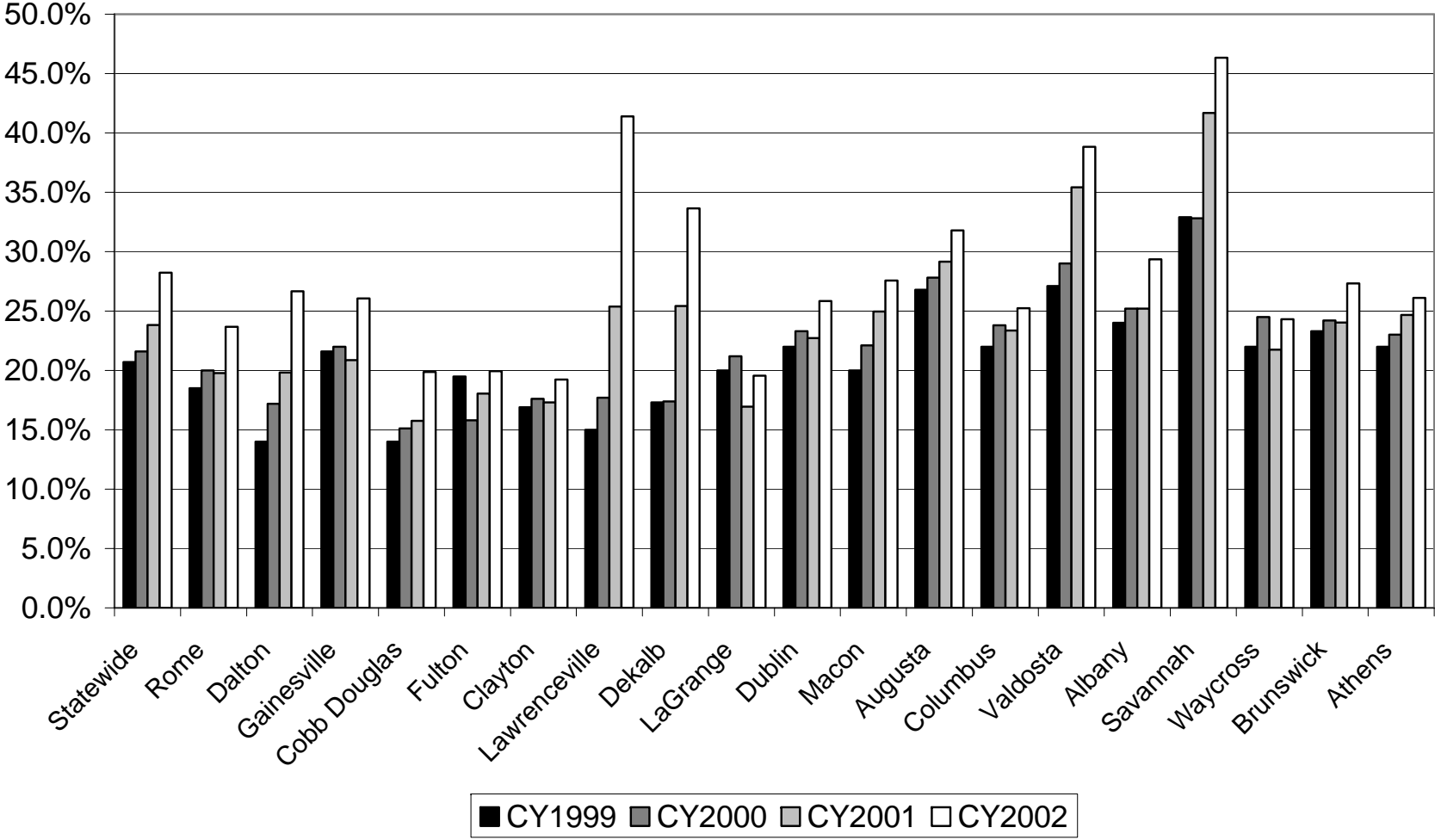


Figure 4A: Medicaid and PeachCare Enrolled Children Who Received Their "Any Dental Service" from a Public Health Dentist, CY2001

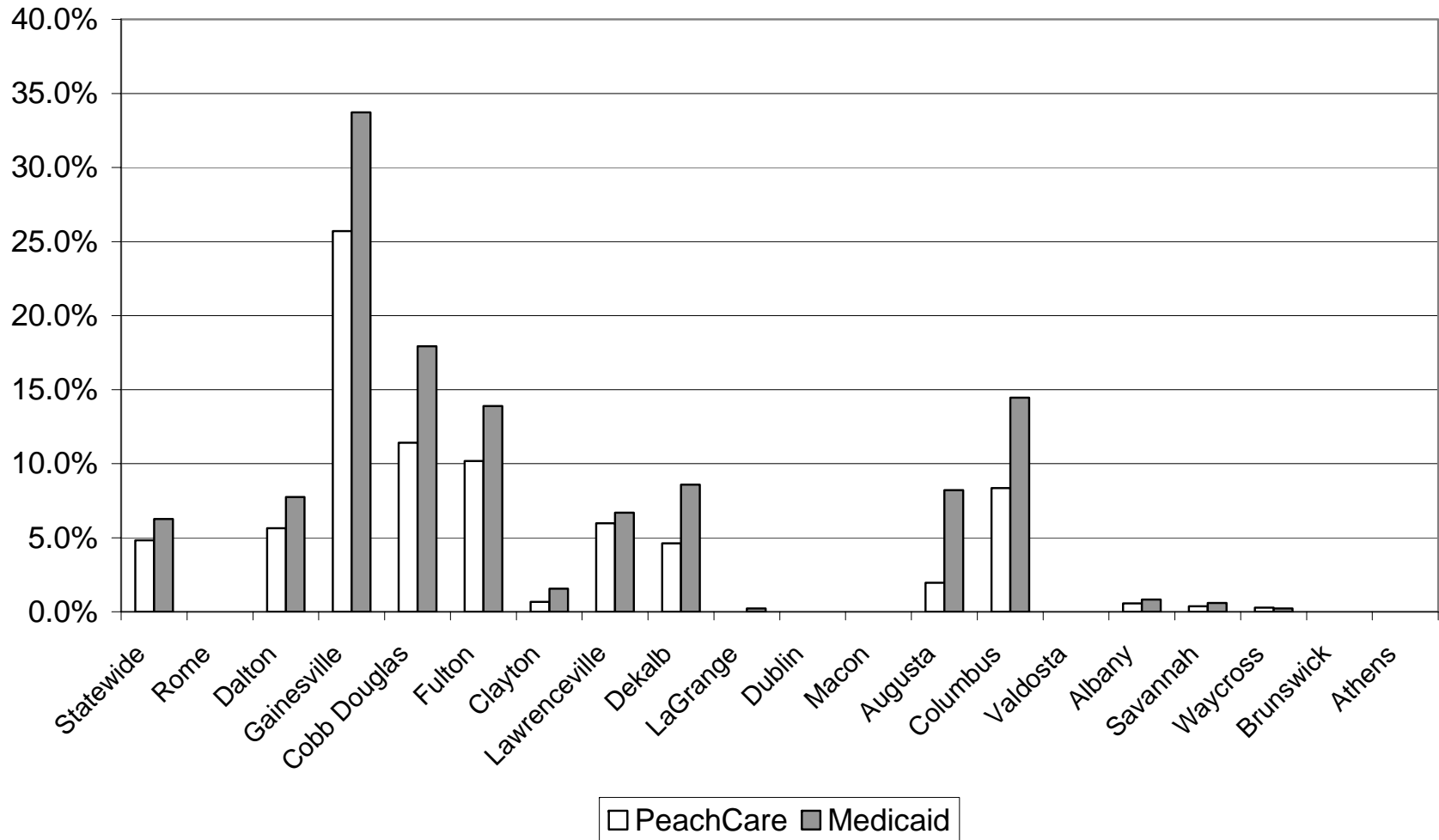


Figure 4B: Medicaid and PeachCare Enrolled Children Who Received Their "Any Dental Service" from a Public Health Dentist, CY2002

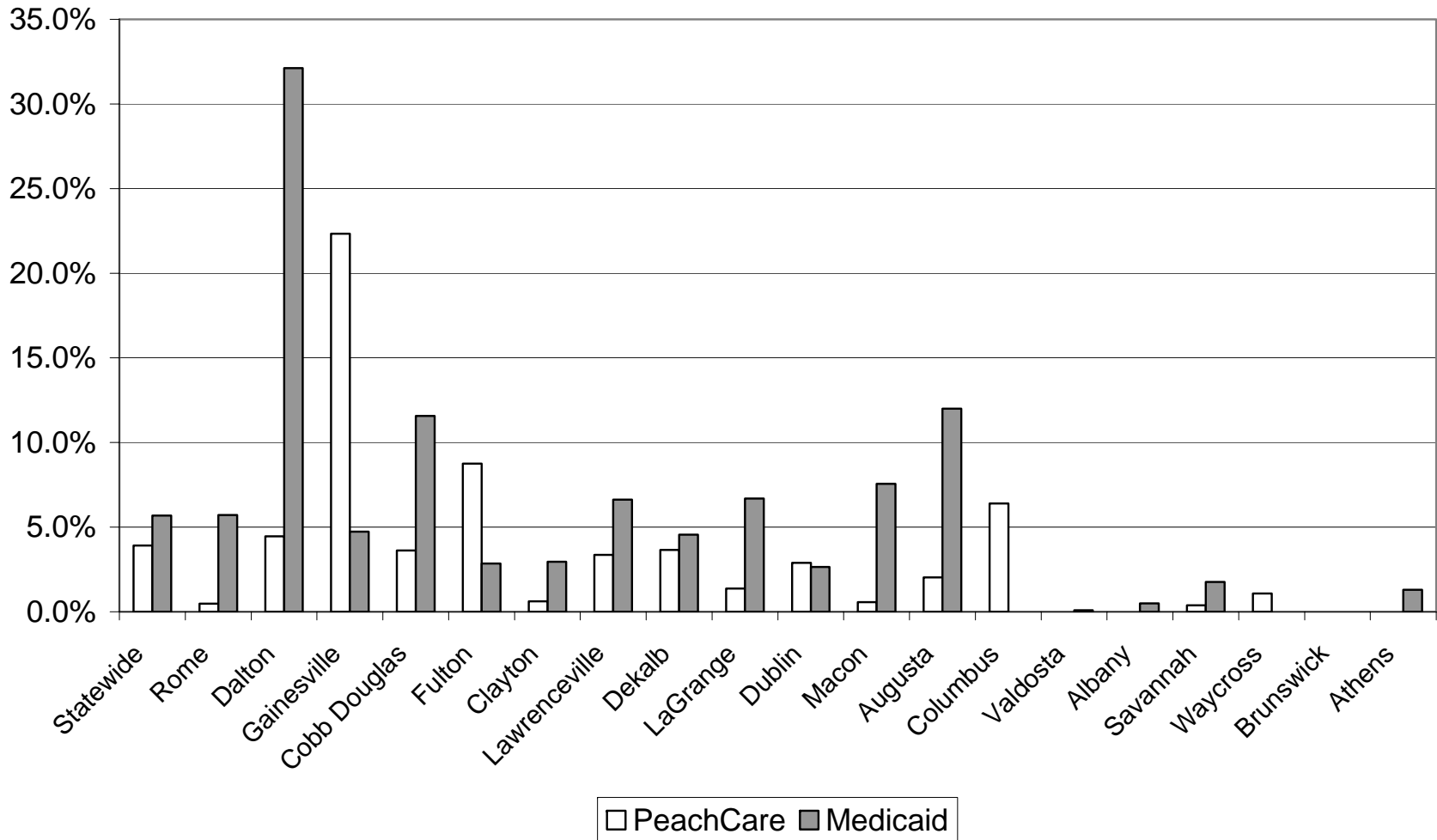


Figure 4C: PeachCare Enrolled Children Who Received Their "Any Dental Service" from a Public Health Dentist, CY2000, CY2001, CY2002

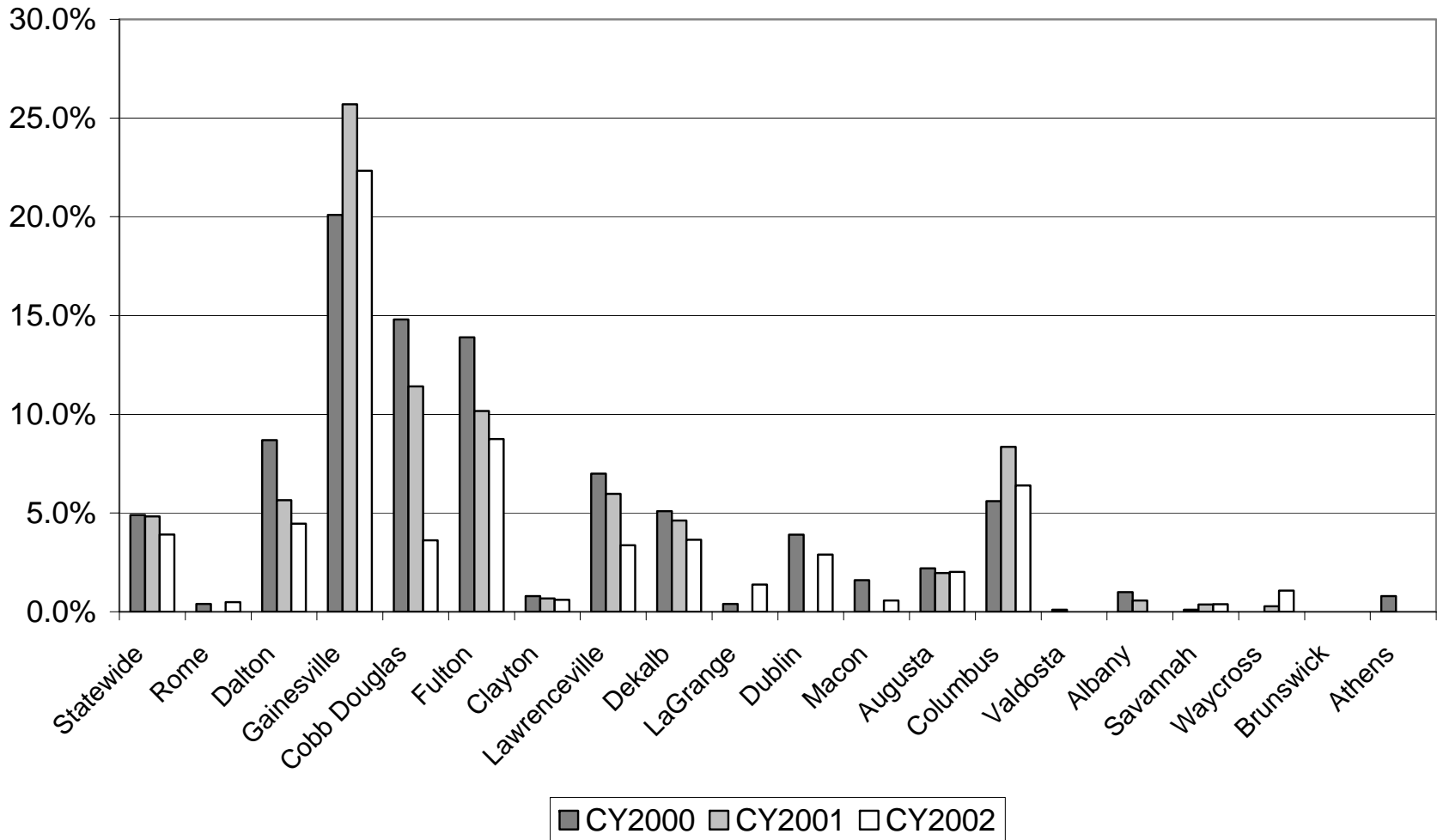


Figure 4D: Medicaid Enrolled Children Who Received Their "Any Dental Service" from a Public Health Dentist, CY2000, CY2001, CY2002

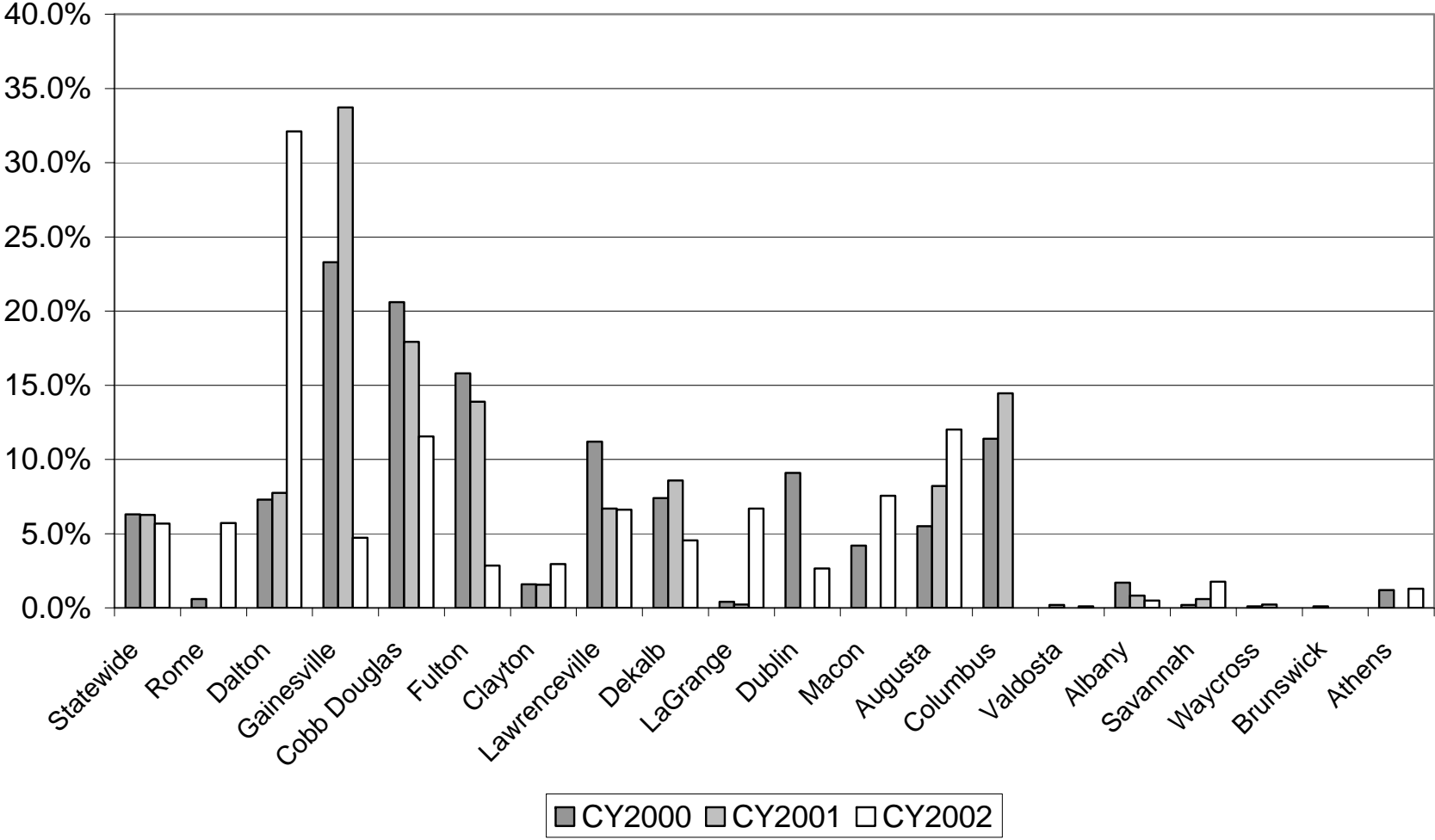


Figure 5A - Percent of Licensed Dentists Participating in Medicaid and PeachCare, CY2001

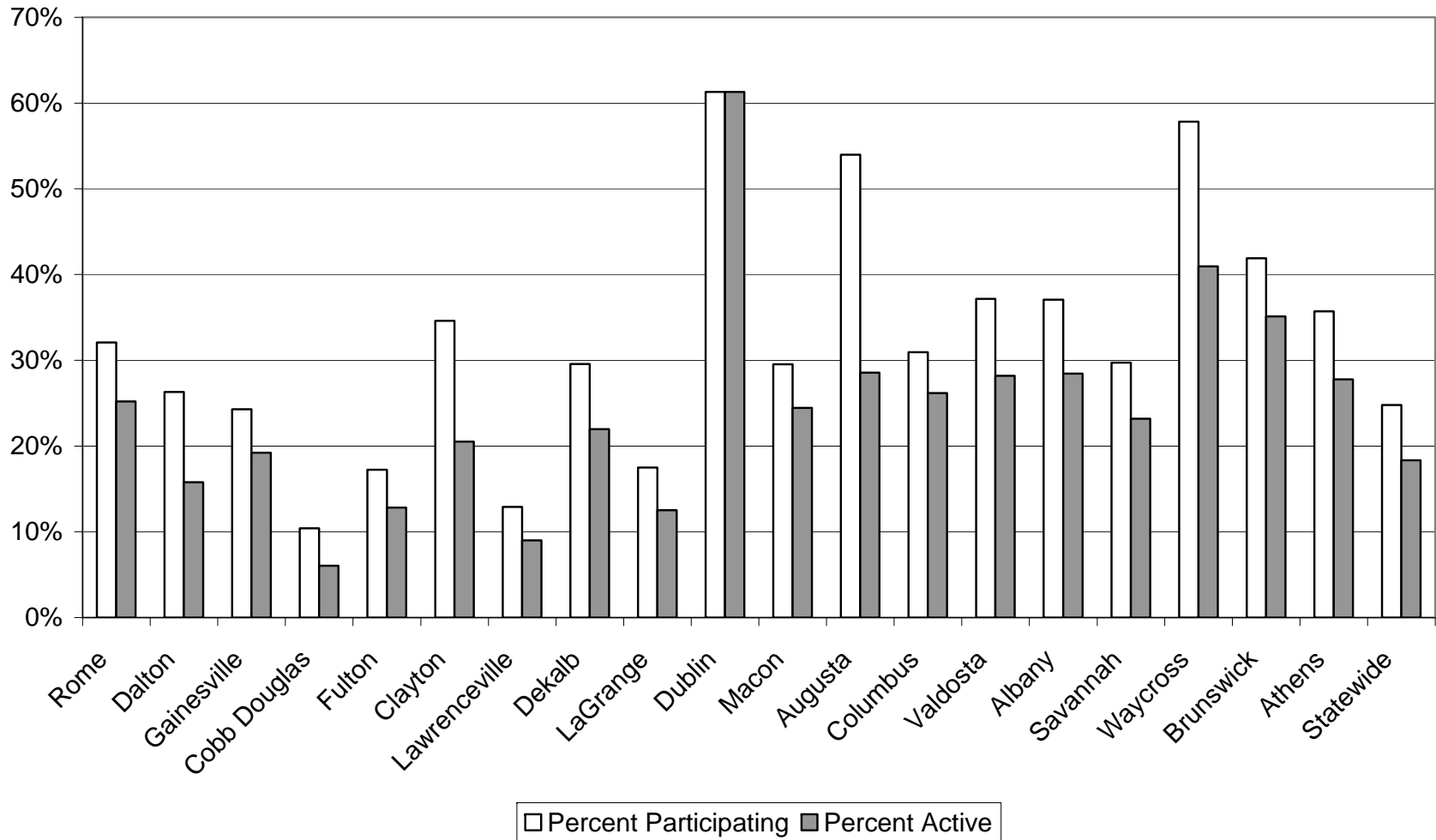


Figure 5B - Percent of Licensed Dentists Participating in Medicaid and PeachCare, CY2002

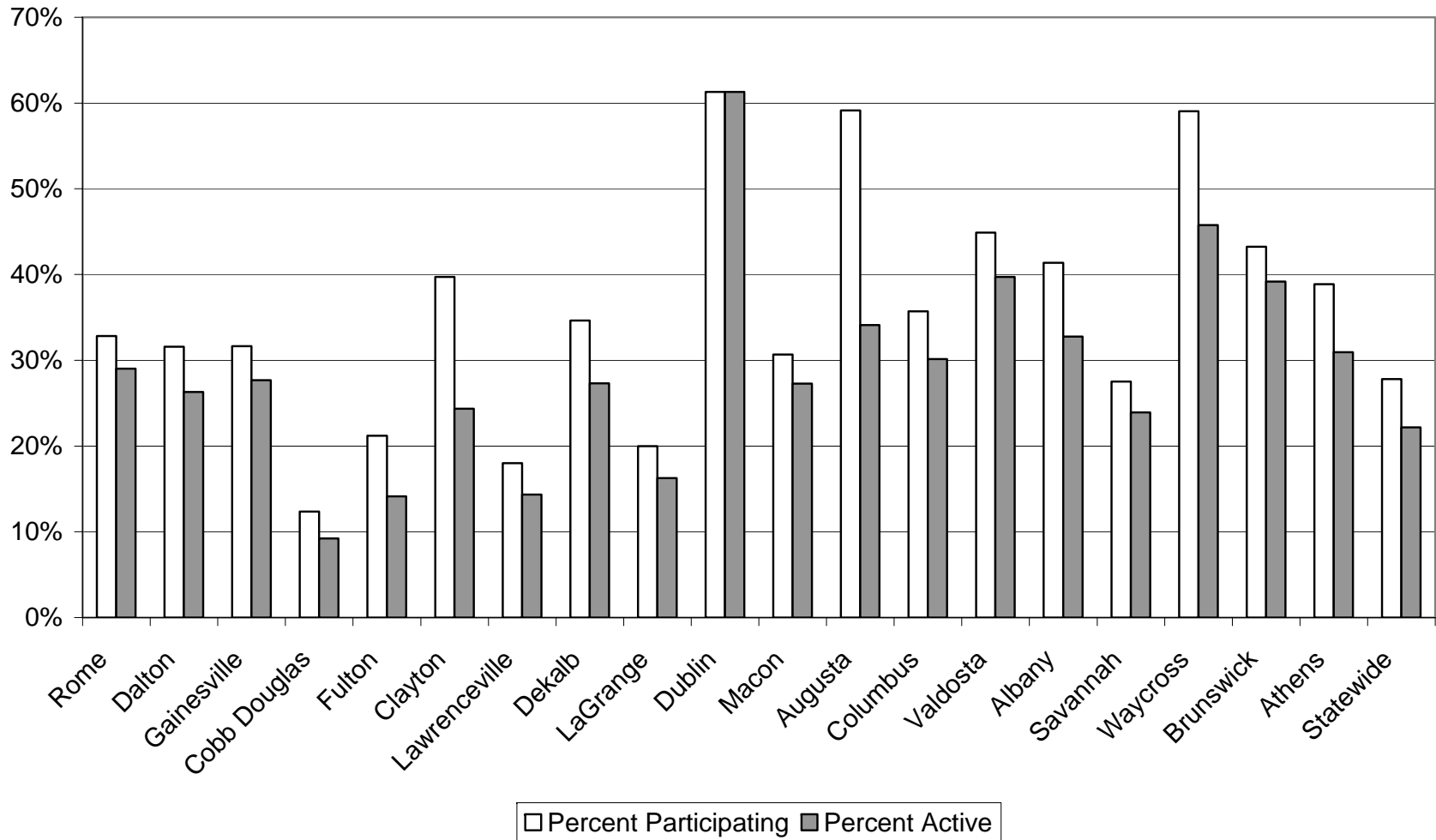


Figure 6 - Total Population Per Dentist By District, FY2003

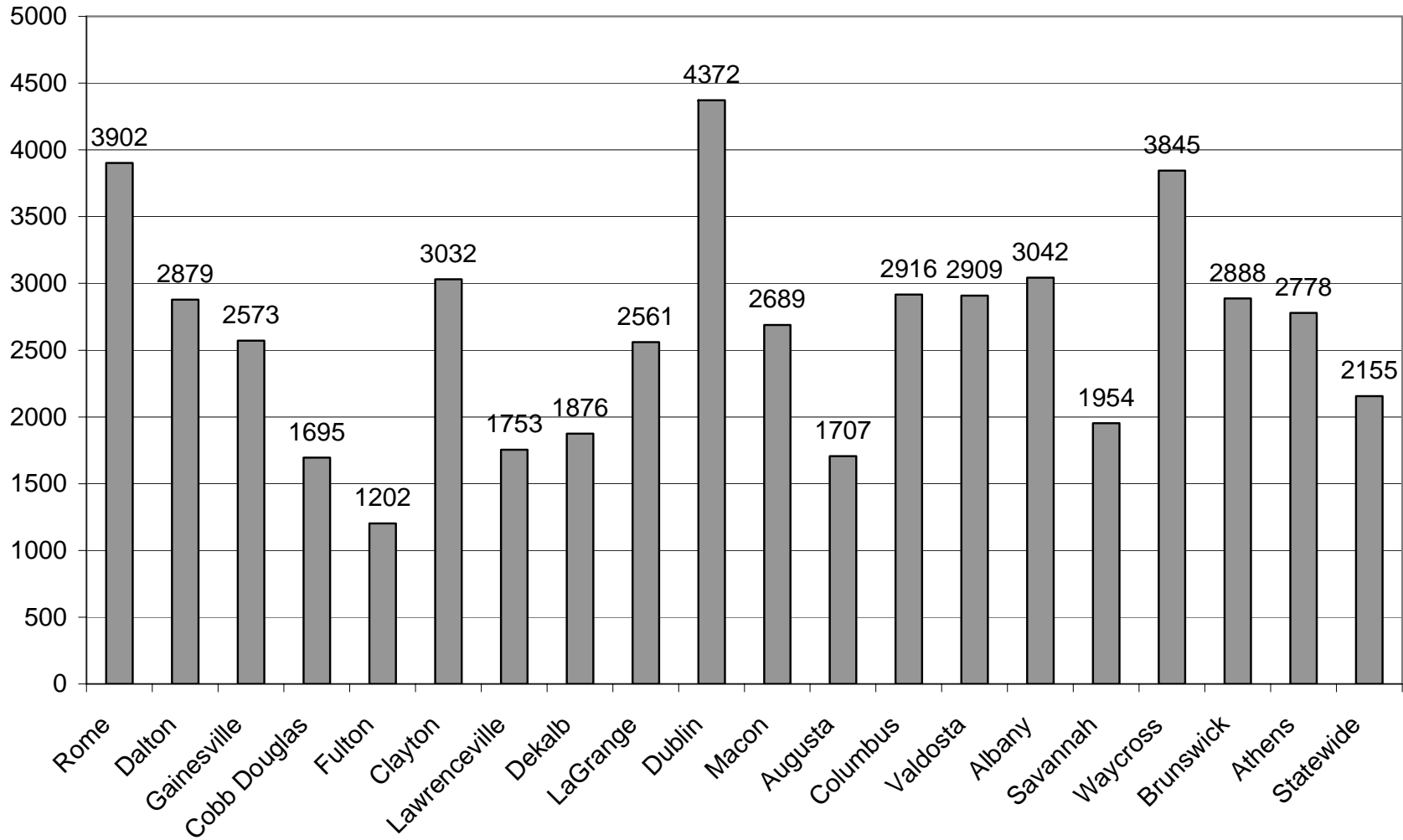
