Carnegie Corporation of New York was created by Andrew Carnegie in 1911 to promote “the advancement and diffusion of knowledge and understanding.” Under Carnegie’s will, grants must benefit the people of the United States, although up to 7.4 percent of the funds may be used for the same purpose in countries that are or have been members of the British Commonwealth, with a current emphasis on sub-Saharan Africa. As a grantmaking foundation, the Corporation seeks to carry out Carnegie’s vision of philanthropy, which he said should aim “to do real and permanent good in this world.”

2006: Striving for Peace and Prosperity, through Education

The growing effects of globalization on societies everywhere, and the pressure for all people to have access to high quality education, have been particular concerns of Carnegie Corporation's grantmaking throughout 2006. "Individuals increasingly recognize that their lot in life depends on their level of education and training," Corporation president Vartan Gregorian wrote in *Newsweek International*. "And states view free or affordable higher education as essential to their modernization and successful participation in the global marketplace."

The United States was still a young nation when the concept of basic education as a right rather than a privilege first gained acceptance. Today's urgent need is for high quality education—the only way workers can keep up with growing global competition. Education experts warn that United States students are steadily losing ground, and only widespread education reform will reverse this trend. The Corporation's Education Division responded with substantial support for a number of

groundbreaking programs, some now in their final stages.

Schools for a New Society has helped school systems reinvent the high school experience to prepare American students for college, economic success and full participation as citizens in a democracy. Given the premise that the teacher is the most important factor in pupil performance, *Teachers for a New Era* has stimulated construction of excellent teacher educa-

tion programs at selected institutions with the aim of achieving the best preparation for the beginning professional teacher. Additional grants have supported efforts toward adolescent literacy, English-language learners and middle school reading programs.

The Corporation's International Development Program focused on higher education as well, the sole mission of the Partnership for Higher Education in Africa – a cooperative effort with the Ford, MacArthur, Rockefeller, William and Flora Hewlett and the Andrew W. Mellon Foundations. Corporation funding went toward enhancing women's opportunities in higher education in the Republic of South Africa; for institutional strengthening and gender equity projects in Nigeria and for education innovations in Ghana. As part of the Revitalizing Public Libraries Program, the University of Cape Town received support toward creation of a university library system that would stand as a model of excellence.

In 2006, the International Peace and Security Program supported projects strengthening the link between biological research and security policy at influential universities and think tanks. The Program's longstanding support of higher education in the former Soviet Union continued with grants to a center for advanced study and education in Belarus; interdisciplinary research and training in the Caucasus; fellowships in the humanities for scholars in the former Soviet Union and executive programs for Russian military officers and policymakers. To address the enduring global challenge of states at risk, myriad research, policy development and state-building programs located primarily at leading U.S. universities and organizations working toward world peace have received considerable support.

Education aimed at creating an informed citizenry was a vital component of programs supported by the Strengthening U.S. Democracy Program. Substantial funding went to activist nonprofits working to promote civil rights, reduce the role of special interest money in American politics, defend campaign spending reforms and protect the right to vote. The education of immigrants—with an emphasis on civics issues—is an ongoing objective of Immigrant Civic Integration programs, which support groups that provide economic, educational and social services to immigrants in the communities where they live, and others, such as the collaborative Four Freedoms Fund organized by Public Interest Projects, that help make immigrant voices heard at all levels of government. Many organizations working toward voting reform and education—ranging from the American Institute for Social Justice to the Common Cause Education Fund to the William J. Brennan, Jr., Center for Justice—all received support, as did others concentrating on youth civic engagement by targeting new voters, providing school-based civic education and conducting a study of young people's attitudes.

Such a list can barely skim the surface of the Corporation's work throughout one year. The Journalism Initiative, for example, entered its second year having achieved curriculum enrichment at four outstanding journalism schools and launching student-led investigative reporting projects that were picked up by a number of the nation's most respected news outlets. The Scholars Program awarded 20 leading scholars grants of up to \$100,000 to pursue Islam-centered research. Their names and pursuits plus a list of the Corporation's wide-ranging efforts to achieve a better educated, more just and peaceful society, here and globally, are on the following pages.

Report on Finances

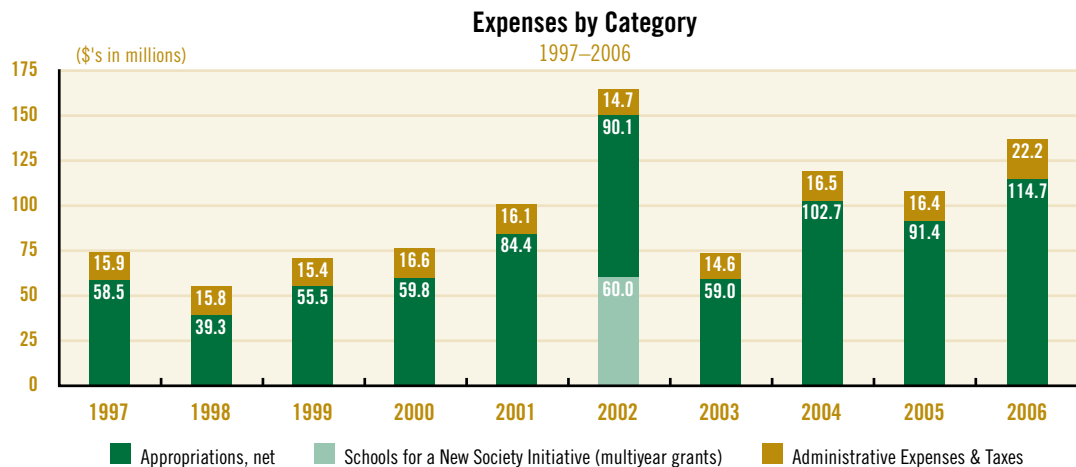
Financial Highlights

Appropriations and Expenses

For the ten years ended September 30, 2006, the Corporation awarded 4,148 grants totaling \$815.5 million and incurred expenses of \$131.4 million for direct charitable activities and

administration expenses, excluding investment expenses, and \$32.9 million for taxes, for a total of \$979.8 million.

The graph below illustrates the growth in expenses by category over the ten-year period ended September 30, 2006.



Each year the trustees appropriate funds to be used for grants and for projects administered by the officers. Many of the grants involve multiyear commitments. In the fiscal year ended September 30, 2006, 48 percent of the appropriated funds were paid within the fiscal year. Appropriations, net of refunds and cancellations and including technical assistance and evaluation services totaled \$114.7 million, compared to \$91.4 million in the preceding year. The increase in appropriations is attributable to the awarding in 2006 of a \$13.6 million grant to the Academy of Educational Development in support of the Corporation's Teachers for a New Era initiative as well as an increase of \$10 million in support of New York City cultural and social organizations from \$20 million in 2005 to \$30 million in 2006.

Program management and direct charitable activities expenses were \$10.9 million in the

fiscal year ended September 30, 2006, compared with \$10.8 million in the previous fiscal year. Included in these amounts, are direct charitable activities of \$3.3 million in 2006 and \$2.8 million in 2005. Direct charitable activities are services provided directly to other exempt organizations, governmental bodies, and the general public. Such services include providing technical assistance to grantees and potential grantees, conducting educational conferences and research, publishing and disseminating educational materials, and serving on boards of other charitable organizations or public commissions.

General administration expenses were \$3.5 million in 2006 and \$3.3 million in 2005.

Taxes

Under the provisions of the Tax Reform Act of 1969, Carnegie Corporation as a private foundation is subject to a federal excise tax of 2 percent on income and realized capital gains. However, under the Tax Reform Act of 1984, the rate is reduced to 1 percent if the foundation maintains its average expense rate of the previous five years and, in addition, spends the tax savings. The Corporation did not meet the requirements for the reduced tax rate in 2006 but did in 2005. Excise tax expense for FY2006 was \$5.4 million. During 2006, the Corporation had unrelated business income of \$6.2 million from certain investment partnership activities. Taxes of \$2.4 million on this income are calculated using applicable corporate tax rates. Deferred tax liability represents the potential tax (at 2 percent) on gains as yet unrealized as well as a book to tax timing difference.

Audit by Independent Accountants

The bylaws provide that the Corporation's accounts are to be audited each year by an independent public accountant. Accordingly, the firm of Goldstein Golub Kessler LLP audited the Corporation's financial statements as of and for the year ended September 30, 2006. The Corporation's financial statements, together with the independent auditors' report, appear on the following pages.

We believe that our audit provides a reasonable basis for our opinion.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Carnegie Corporation of New York as of September 30, 2006, and the changes in its net assets and its cash flows for the years then ended in conformity with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

September 30, 2006 and 2005

(1) ORGANIZATION:

Carnegie Corporation of New York (the "Corporation") is a philanthropic grantmaking foundation that was created by Andrew Carnegie in 1911 to promote the advancement and diffusion of knowledge and understanding. The Corporation has a policy of selecting a few areas at a time in which to concentrate its grants. The Corporation is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code; however, the Corporation is liable for Federal excise taxes (See note 5).

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The accompanying financial statements have been prepared on the accrual basis of accounting.

Fixed assets are stated at cost. Depreciation is calculated on a straight-line basis over the estimated useful lives of the related assets ranging from five to ten years. Leasehold improvements are amortized over the remaining life of the lease.

Grant appropriations, including multi-year grants, are recorded as an expense and a payable when grants are approved and communicated to the grantees. Grants payable is expected to be paid as follows: approximately \$59 million within one year and the remaining balance within three years.

For purposes of the statements of cash flows, cash includes all cash held in bank accounts at September 30, 2006 and 2005.

The resources of the Corporation consist of permanently restricted and unrestricted net assets. Permanently restricted net assets represent the original sums received from Andrew Carnegie who, by the terms of the conveying instrument, stipulated that the principal may never be expended; however, the income is expendable. Unrestricted net assets are not subject to donor-imposed restrictions. Contributions are recognized as revenues in the period received. All revenues in 2006 and 2005 were unrestricted or were restricted and released from restriction during the same period.

The Corporation serves as a fiscal agent for the benefit of specified school districts participating in the Corporation's Schools for a New Society initiative and provides technical assistance and evaluation services to said districts. In the accompanying financial statements, \$858,451 was recorded as revenue in 2006 and \$1,141,549 in 2005; \$858,451 was recorded as accounts payable and other liabilities in 2005 for fees for technical assistance and evaluation services.

The fair value of investments has been determined as indicated in note 3. The carrying amounts of the Corporation's other financial instruments approximate fair value because of their short maturity.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

(3) INVESTMENTS:

Readily marketable investments are reported at fair value on the basis of quoted market prices. Limited partnerships and similar interests are reported at fair value based on financial information received from the fund managers or general partners. The fund managers or general partners determine the fair value of securities using quoted market prices, if available, or using other valuation methods. Investments in limited partnerships and similar interests totaled \$2,027,306,742 at September 30, 2006 and \$1,637,217,557 at September 30, 2005.

Included in the table above is accrued investment income of \$2,046,318 and \$2,374,958 at September 30, 2006 and 2005, respectively.

At September 30, 2006, the Corporation had unfunded capital commitments of approximately \$607 million in various limited partnership investments.

During the reporting period, the Corporation received distributions of marketable securities with a total fair value of approximately \$7.8 million from limited partnerships.

In certain cases, the Corporation uses swap contracts to invest in real estate limited partnerships. As of September 30, 2006, the fair value of these swaps, which are included in investments, was approximately \$17.2 million. Swap contracts are subject to off-balance-sheet risk mainly due to the credit risk arising from the potential inability of the counterparty of the swap to perform under the terms of the contract. Based on the specific structuring of these swap contracts, the Corporation's exposure to credit risk associated with counterparty nonperformance is limited to the unrealized gain on each contract. To reduce this risk, the Corporation only enters into swaps with major U.S. broker-dealers.

Notes to Financial Statements

September 30, 2006 and 2005

As a result of its investing strategies, the Corporation is a party to financial futures contracts. The Corporation's fixed income investment manager uses treasury index futures contracts to manage the duration of the fixed income portfolio. Changes in the market value of these futures contracts are recognized currently in the statements of changes in net assets, using the marked-to-market method. However, index futures contracts involve, to varying degrees, elements of market risk and credit risk in excess of the amounts recorded on the balance sheets. Market risk represents the potential loss the Corporation faces due to the decrease in the value of the financial instruments in the table below. Credit risk represents the potential loss the Corporation faces due to the inability of counterparties to meet the terms of their contracts.

The margin requirements on deposit with third-party safekeeping banks for futures contracts were approximately \$41,000 at September 30, 2006 and \$203,000 at September 30, 2005. The partnerships in which the Corporation invests may also hold futures and options. These positions are not included in the table above.

The Corporation permits its investment managers to use forward foreign currency contracts to manage the currency risk inherent in owning securities denominated in foreign currencies. In a forward foreign currency transaction, the Corporation agrees to exchange one currency for another on an agreed-upon date at an agreed-upon exchange rate. At September 30, 2006, the Corporation held no forward contracts to buy or sell foreign currencies. At September 30, 2005, the Corporation held forward currency buy contracts and sell contracts with notional amounts totaling \$.5 million. Such contracts involve, to varying degrees, risks of loss arising either from the potential change in exchange rates or from the possible inability of counterparties to meet the terms of their contracts. Forward foreign currency contracts are carried in the balance sheets at fair value. Changes in the value of forward foreign currency contracts are recognized as increases or decreases in unrealized appreciation or depreciation until such contracts are closed.

Notes to Financial Statements

September 30, 2006 and 2005

The Corporation's investment advisors monitor the financial condition of the firms used for futures and forward foreign currency trading in order to minimize the risk of loss. Exposure limits are placed on firms relative to their creditworthiness. Management does not anticipate that losses, if any, resulting from credit or market risk would have a material adverse effect on the financial statements.

(5) TAXES:

The Corporation is liable for Federal excise taxes of two percent of its net investment income, as defined, which includes net realized capital gains, for the year. However, this tax is reduced to one percent if certain conditions are met. The Corporation did not meet the requirements for the reduced tax in 2006 but did in 2005. Therefore, current taxes are estimated at two percent of net investment income, as defined, for 2006 and at one percent for 2005.

Deferred taxes represent two percent of unrealized appreciation of investments at September 30, 2006 and 2005, as qualification for the one percent tax is not determinable until the fiscal year in which gains are realized.

During 2006 and 2005, the Corporation had unrelated business income of \$6,200,500 and \$2,460,700, respectively, from certain investment partnership activities. Federal and state taxes of \$2,445,800 in 2006 and \$843,200 in 2005 on this income are calculated using applicable corporate tax rates and are included in the provision for taxes.

The Corporation paid Federal excise taxes of \$4,706,000 in 2006 and \$1,800,000 in 2005. The Corporation also paid Federal and state unrelated business income taxes of \$2,279,100 in 2006 and \$769,700 in 2005.

(6) BENEFIT PLANS:

The Corporation purchases annuities for qualifying employees under the terms of a noncontributory, defined contribution retirement plan with Teachers Insurance and Annuity Association and College Retirement Equities Fund. Retirement plan expense for the years ended September 30, 2006 and 2005 was \$1,120,400 and \$1,080,300, respectively.

In addition, the Corporation has a noncontributory defined benefit annuity plan to supplement the basic plan described above. This plan is also administered by Teachers Insurance and Annuity Association and College Retirement Equities Fund. Contributions to this plan are based on actuarial calculations. No contribution was required in 2006 or 2005. At December 31, 2005, the assets of the plan exceeded the actuarial present value of accumulated plan benefits by approximately \$568,000.

In addition, the Corporation provides certain medical benefits to its retirees. The cost of providing these benefits was \$216,800 in 2006 and \$204,100 in 2005, on a pay-as-you-go basis.

(7) LEASES:

The Corporation occupies office space at 437 Madison Avenue under a lease agreement expiring December 31, 2013.

Report on Administration

Fiscal 2006: The Year in Review

Alan Pifer, president of Carnegie Corporation of New York from 1967 until 1982, passed away on October 31, 2005, at age 84. (Previously, he had been acting president from 1965 to 1967.) During his tenure, the Corporation's landmark achievements included support for projects that challenged South Africa's apartheid policies, helped to establish Pell grants that enabled thousands of students to attend college, and promoted children's educational television. Alan Pifer's deep commitment to advancing social justice and strengthening the rights of the disadvantaged led to these issues becoming hallmarks of the Corporation's work during his presidency.

Board and Committees

Ana Palacio and Amy Gutmann were elected to four-year terms as trustees, beginning December 1, 2005. Susan Hockfield was elected to a four-year term effective September 28, 2006.

Ms. Palacio is Senior Vice President and General Counsel for The World Bank. Dr. Gutmann is president of the University of

Pennsylvania. Ms. Hockfield is president of the Massachusetts Institute of Technology.

Annual elections were held at the December 1, 2005, board meeting. The trustees elected Helene L. Kaplan as chairman and Martin Leibowitz as vice-chairman.

The board elected members to serve on various committees for calendar year 2006. The Corporation's four standing committees

were constituted as follows: on the planning and finance committee were Martin Leibowitz, Olara Otunnu and Raymond Smith, who was elected chair by committee members; on the audit committee were James Hunt, Martin Leibowitz, Thomas Pickering, Raymond Smith, and Pedro Aspe, chair; the committee on trustees included Bruce Alberts, Richard Brodhead, James Hunt, Thomas Kean, William Owens, Richard Riley, and Olara Otunnu, chair; and on the investment management committee were Fiona Druckenmiller, Martin Leibowitz, Raymond Smith, and Geoffrey Boisi, chair.

The board also elected members to four program committees: on the education committee were Geoffrey Boisi, Richard Brodhead, Fiona Druckenmiller, Amy Gutmann, James Hunt, Martin Leibowitz, Olara Otunnu, Richard Riley and Janet Robinson; on the international development committee were Pedro Aspe, Richard Brodhead, James Hunt, William Owens, Ana Palacio, Norman Pearlstine and Raymond Smith; on the international peace and security committee were Bruce Alberts, Pedro Aspe, Geoffrey Boisi, Amy Gutmann, Thomas Kean, William Owens, Ana Palacio, Norman Pearlstine, Thomas Pickering and Raymond Smith; and on the Strengthening U.S. Democracy program and Special Opportunities Fund committee were Bruce Alberts, Fiona Druckenmiller, Thomas Kean, Martin Leibowitz, Olara Otunnu, Thomas Pickering, Richard Riley and Janet Robinson.

Both Helene L. Kaplan, chairman of the board, and Vartan Gregorian, president of the Corporation, serve *ex officio* on all standing committees. Membership on the ad hoc committee on compensation includes the chairman of the board, Helene L. Kaplan, vice chairman

of the board, Martin Leibowitz, chair of the investment management committee, Geoffrey Boisi, and chair of the planning and finance committee, Raymond Smith.

Board Actions

At the September 29, 2005 board meeting, the proposed audit plan for fiscal year 2005-06 was discussed and accepted.

At the board meeting on March 2, 2006, the trustees resolved to accept a gift of \$30 million from an individual who wished to remain anonymous. The trustees authorized the president to appropriate those funds in a manner consistent with the Corporation's mission and the donor's general intent. The grants supported small- and medium-sized arts and cultural institutions, and social services providers throughout New York City.

Milestones

During fiscal year 2006, there were a number of staff changes as the Corporation recognized professional growth with promotions, expressed appreciation to departing staff members, and welcomed new people to the foundation.

Joining the Corporation in fiscal year 2006 were Adrienne Faraci, communications coordinator for Public Affairs and Claudia Frittelli, program associate for the International Development Program.

The Corporation bid farewell to Idalia "Dee" Holder, director of human resources; Alexis Palmer, investment associate and Grace Walters, coordinator for public affairs and media relations.

Upon her retirement, Dee Holder received a minute of appreciation for her 32 years of service to the Corporation. The minute read in part: “You have been a thoughtful, responsible and creative colleague through more than three decades, and all those who have had the pleasure and privilege of working with you are grateful for the experience.”

In fiscal year 2006, Rick Brown was promoted from systems technician to network specialist. Natasha Davids, administrative assistant, was promoted to executive assistant.

Report on Investments

Corporation's Investment Performance Strong; Portfolio Exceeds \$2.5 Billion, Highest Valuation in Its History

During the five years since the terrorist attacks of September 11, 2001 global markets have seesawed: declining sharply during the credit crunch, insolvencies, and technology melt-down that occurred during the first half of the period, and then rebounding with similar vigor as record low interest rates, ample liquidity, and worldwide economic strength fueled demand for assets across the board. Guided by the tenet that the Corporation's assets constitute a perpetual pool of capital, the Corporation's investment program is designed to weather market swings and generate meaningful returns over the long-term. Through diligent manager selection and asset allocation decisions, the Corporation has succeeded in achieving its goals of maintaining purchasing power net of spending, and growing its capital corpus: over the past five years, the Corporation's assets grew from \$1,710 million to \$2,528 million,

the highest valuation in its 95-year history. At the same time, the Corporation disbursed \$492 million for grants and administrative expenses, representing a spending rate of 5.1 percent of total assets. Unlike many foundations, the Corporation was able to maintain its spending during the technology downturn thanks to the foundation's diversified approach to investing and its spending rule of 5.5 percent of its 12-quarter average market value, which smoothed the volatility of disbursements.

Fiscal year 2006 proved to be an exceptional period for the Corporation's investment portfolio. With a return of 17.2 percent, the Corporation's performance ranked near the top among the 72 institutions surveyed for the Cambridge Associates' Over \$1 Billion Non-taxable Universe—a testament to the Corporation's disciplined, value-oriented, long-term

investment philosophy, execution by a professional staff, and the support by an engaged, policy-oriented investment committee. The Corporation's annualized returns over the past three fiscal years have also been robust at 17.1 percent, putting the Corporation in the top quartile of non-taxable institutions included in the Cambridge Associates' Over \$1 Billion Universe. Despite lower returns experienced during the technology crash of 2001 and 2002, the portfolio achieved an annualized return of 13.7 percent over the past five fiscal years, easily ranking the Corporation's performance within the top decile of the Cambridge universe; while on a ten-year basis, returns of 11.7 percent outpaced its benchmark of 8.9 percent by a significant margin. The Corporation's investment performance over the decade ending September 30, 2006, is illustrated below.

Adherents to the principles of modern portfolio theory, the Corporation's staff endeavors to optimize asset allocation decisions (as reflected in the Corporation's policy or target allocation) bearing in mind the return profiles, risk characteristics, and correlations among competing asset classes. In comparison to peer institutions, the Corporation has a relatively high policy allocation to Emerging Markets and Real Estate & Resources—an

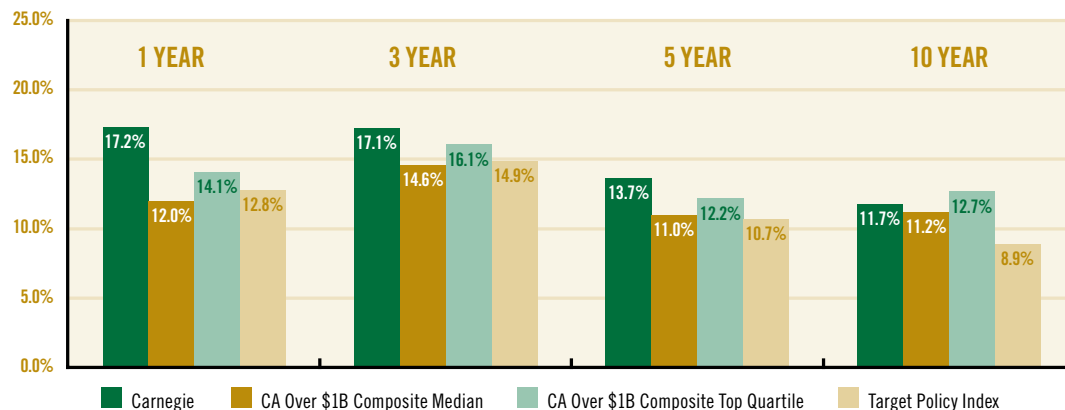
approach that has served it well—and relatively lower exposure to Developed Market Equities, particularly domestic names. The Corporation's asset allocation as of September 30, 2006, is illustrated on the following page.

Outstanding performance from public equity strategies and alternative investments, including Absolute Return strategies, Private Equity and Real Estate & Resources buoyed results on a one-, three- and five-year basis:

- The Corporation's Global Equity portfolio—its largest asset allocation—performed well during these periods, producing returns of 18.0 percent, 19.6 percent, and 16.4 percent, respectively, with Emerging Markets contributing significantly to these strong returns.
- Absolute Return produced net returns of 11.5 percent, 14.2 percent, and 12.4 percent, respectively, thanks to managers' canny security selections, focus on company fundamentals, and a willingness to take concentrated positions in high conviction investment ideas;
- Private Equity returned 32.3 percent, 22.9 percent, and 13.1 percent, respectively, exceptionally strong numbers that reflect a recovery in venture capital and a buyout environment rich with exit opportunities to both financial

and strategic buyers. Private Equity's performance is all the more remarkable given that the Corporation has low exposure to mega-buyout funds that have recently delivered some of the highest returns in the space; and,

- Real Estate & Resources returned 25.2 percent, 24.3 percent, and 15.7 percent, respectively, an impressive run fueled by the willingness of the Corporation's managers to sell properties into a market awash in liquidity and hungry for yield. The Corporation's exposure to Resource-related strategies, notably upstream oil and gas investments, also paid dividends as commodity prices surged upward.

The Corporation will occasionally tactically over- and under-weight particular asset classes within pre-specified ranges. For example, the Corporation has been tactically-overweight Emerging Markets over the past few years, given the staff's belief in its relative value and continued potential to generate strong earnings growth. This move has paid handsome dividends to the Corporation: on a one-, three- and five-year basis, the Corpora-

tion's Emerging Markets portfolio generated net returns of 25.5 percent, 30.0 percent, and 29.1 percent, respectively, making it the best performing asset class in the portfolio during that period. The Corporation continues to make public and private equity commitments to the space, including niche managers well-positioned to capitalize on the seismic changes unfolding in China and India. On the other hand, the staff has tactically underweighted Fixed Income, owing to low interest rates, tight credit spreads and benign volatility, making the asset class, in the staff's view, less likely to generate strong absolute returns.

Valuations of financial assets remain rich across categories and in every region of the world, a situation we and many others have observed for several years now. Despite the consensus that the recent run-up in world markets is overextended, assets and securities continue to trade upward. Markets eventually correct, and as such we would expect returns going-forward to be more modest than those of the past decade. How and when this transpires

^{*} The target policy benchmark provides a way to compare the performance of the Corporation's portfolio with appropriate market indices. Each of the portfolio's asset classes has a benchmark; the policy benchmark is calculated by multiplying the actual return of an appropriate market index (such as the S & P 500) for each class of assets by the percentage of the Corporation's portfolio that is allocated to that class. The total policy benchmark, the sum of these benchmark calculations, provides an overall measure of actual performance relative to market indices.

is the great unknown. The Corporation has clearly benefited from healthy markets, with Fiscal 2006 marking a truly remarkable and historic year for the portfolio. But the Corporation's portfolio is also positioned defensively to do well in a challenging environment given its substantial diversification, emphasis on fundamental manager research, and bottoms-up security selection. Given the perpetual mandate and irreplaceable nature of the Corporation's asset base, optimizing returns on a risk-adjusted basis over the long-term remains the investment program's lodestar—an ambitious but, we believe, achievable goal provided the Corporation's investment discipline remains intact, whatever markets may bring.
